Community Governance in US Cities

Introduction:

This course will simulate the formation and early years of a new city. The idea is to expose students to a realistic example of community governance in the western United States.

Most cities in the United States are very small compared to Chinese cities. Regardless, the lessons and challenges of a typical formation should provide insights for all those holding an interest in community governance.

Course Methods:

Each day the students will address a new challenge. Lessons will enable thoughtful decisions that can lead to a successful result. Lessons will include political, financial, and legal challenges associated with community building. A final paper is due at the final class, which will include a summary of the lessons learned. The papers will be presented during this final class.

During class exercises, students will be asked to propose solutions as though they were a city official whose job was to help set policies for the new city.

The class will include an actual feasibility study on the formation of a city in the northwest United States. Portions of this study will be used in class exercises, to provide a realistic framework. However, the students' cities must be created from their own imaginations.

Course Requirements:

Students must complete their study assignments, attend class daily, participate in class discussions, and write a final paper. Up to 70 points will be based on class preparation and participation. The remaining 30 points will be based on completion and presentation of the final paper.

All classes will be important. Each unexcused absence will yield a 5% reduction in the final grade.

 - The county has 9 elected officials, each with separate but interconnected duties. These include:
 - An elected Sheriff, the chief law enforcement officer for the county
 - An elected Prosecuting Attorney, whose job is to be the lawyer for the county
 - An elected County Treasurer, who manages money for the county
 - An elected Assessor, who oversees appraisals of all properties in the county, which serve as the basis for property tax collections (the higher the appraial, the higher the tax).
 - An elected Auditor, whose job is to oversee county elections, and to ensure that the county manages its money in accordance with state laws
 - An elected Coroner, whose job is to determine cause of death whenever someone dies in the county
 - Three commissioners, who oversee all other county functions not led by separately elected officials and who control the budgets of all departments.
 - County Finances are very weak as a result of the recession
 - Due to the recession, county income has been dropping, and couny commissioners have cut the budgets of all departments, including the Sheriff.

- The Sheriff has publicly raised objections to these custs, raising concerns over the Commissioners' commitment to public safety.
- County Sheriff has committed to providing specific police services for the next 3 years. The price matches with the consultant report estimate. However, there is no guarantee that he will maintain that price after the 3 years. Also, considering the pending cuts, you may not believe he will be able to maintain services at the level he has committed to.
- The County Commission must sign off on any contract, and may not agree to accept the agreement negotiated by the Sheriff.

 - The existing community is made up of homes on lots averaging ½ acre in size. Retail development includes about 500 meters of shops and stores, scattered along both sides of one roadway. There are about 20 4-unit buildings near this area. There is no job center.

 - There are vacant lands on the south side of the city near a rail line and major highway.

- It is one year after incorporation of the city.
- Currently all city residents treat their sewage with on site septic systems
- In the past few years, several wells have become contaminated. The soure of contamination is likely from the on site septic systems.
- Also, in order to develop the industrially zoned lands, sewer service will be required by state law and will be an expectation of future industrial land users.
- Two miles away from the city is a sewer district. As the name implies, its purpose is to provide sewer service for homes and businesses connected to its system. It has its own employees and elected board of directors. It owns a treatment plant and a distribution system.
- You have approached the district manager about connecting to their system. He has agreed to connect, but there are his terms:
 - The city must pay for the entire cost (\$10,000,000).
 - As city residents connect, they must pay a \$5,000 connection charge and the city must forward it to the district. (This is so the district can set aside money to pay for additional capacity at the district's sewer plant.)
 - The city must pay for an "oversized" line, making it larger than what is necessary to transfer city sewage to the district's plant.
 - The district will offer sewer service to potential developers along the pathway of the new line, and will not require any of the new connectors to commit to future annexation into the city.
 - The county, which regulates land use in the area, is likely to allow high density development, regardless of the impacts, in order to collect the building permit revenues and sales taxes associated with the construction.
- Development along the sewer line would create car traffic problems for city residents who drive daily on this road to a larger city where many of them are employed.
- City plans include residential growth north of the city, not south of the city.
- Alternatively, the city may develop its own sewer plant and collection system. This will cost \$80,000,000.

- Early site analysis has turned up spilled chemicals that probably came from adjoining railroad track, although there is no way to know for sure. Officials at the railroad will not return your phone calls or emails to them asking about the subject.
- The land owner's banker will not loan money for the development unless the owner cleans up the property. Preliminary estimates are that the cleanup cost will exceed the value of the land.
- The state has learned about the problem and demanded that the owner clean up the land.

 - Evaluate the list of expenses on Exhibit 17 (page 48) of the Birch Bay Feasibility Study. Allocate \$5,300,000 in total revenue amongst the various items according to your own group's preferences for your city. Assumptions: The Sheriff's contract for service \$1.3 million per year according to

the agreement you have negotiated with the Sheriff and County Commission. Establish amounts for all the remaining items, and explain why you established these for the rest. Assumption: If you did not select Council-Manager as your form of government assume that the relevant line item is labeled "Administration."

- Establish an ideal amount you should retain in cash reserves. Explain the reasons you believe that this amount is the correct amount
- Within the next few years, you will start up a city police department. Create a plan that facilitates this goal, including the date you intend to transition away from the Sheriff.

Assumptions: It will cost \$1.3 million annually to house and equip the new police department. Operational expenses are not an issue because they will match the amount you are paying the county.

- Create a 6 year park and recreation spending plan, including year by year expenditures over the next 6 years.
- Make a decision on the Questions raised in Classes 5 and 7. Decide what to do
 with the contaminated land and explain your reasons.
- Decide whether to plan for connection the neighboring sewer district or to develop the city's own sewer utility. Explain your reasons.
